

Parent/Player Code of Conduct:

To avoid incidents at any Warriors Nation Basketball (WNB) aka Reaching All Youth, Inc. (RAY Inc.) events, the Parent/Player Code of Conduct is to be adhered to by all spectators & players at all our events.

1. I will show good sportsmanship by demonstrating positive support of all players, coaches, contest administrators and officials at every game.
2. I will place the emotional and physical wellbeing of the athletes ahead of my personal desire to win.
3. I will encourage a sport environment that is free from drugs, tobacco, alcohol, profanity and will refrain from their use at all WNB aka RAY Inc. events.
4. I will remember that the games are for the kids to play - not the adults.
5. I will make sure that youth sports are a FUN and POSITIVE experience.
6. I will treat other players, coaches, fans, volunteers, and OFFICIALS with RESPECT regardless of race, gender, creed, or ability. (Disrespect is not tolerated on any level).
7. I will not undermine the coaches' interactions or directions. (PARENTS NO COACHING YOUR CHILD FROM THE SIDELINE) (1st is a warning; 2nd occurrence is player suspension. 3rd is banishment from the team)
8. I acknowledge that I was given a tentative AAU schedule with the breakdown of fees and that no refunds would be given under any circumstances. (No prorations)
9. I will not approach the Coaches during games and practices for personal concerns. All disputes or concerns must be handled by appointments or asking the Coach when a good time is to discuss any situation/concerns. (Remember, Coaches are all volunteers)
10. I understand that I must arrive on time to pick up my child (1st occurrence is a warning, 2nd occurrence will result in suspension of your child; 3rd occurrence may result in dismissal from team)
11. I understand that my child is not guaranteed game minutes (Minutes are earned, not given).
12. A player will never ask a Coach when they are going into the game, nor if they are going in.
13. I understand that if my child damage, lose or misplace their uniform, the cost is \$125 to purchase a replacement uniform.
14. I understand that the players are in the custody of the coaches during practice, tournaments, and team events. They may not leave to interact with friends, parents, or other family members unless coach has dismissed or given them permission. (Please provide your child a drink before the game, not during the time coaches are meeting with their players)
15. A player is not dismissed from practice, games, or team meetings until coaches dismiss them.
16. Parents are not allowed on the bench sideline for practice or games. (unless coaches invite you)

17. Coaches hold the right to have a closed practice. (Only players allowed in the gym on private practices).

18. I understand that my child missing or tardy to practice and/or games may result in loss of game time. (Exception is school events or major injury only. Doctor note needed to return from an injury).
